THIS PROGRAM PROVIDES SHELTER AND CARE FOR ALL HOMELESS ANIMALS, ADOPTION SERVICES, LOST & FOUND PET SERVICES, BEHAVIOR MODIFICATION FOR SHELTER PETS AND DOG TRAINING FOR THE PUBLIC. IN 2019, OUR SHELTER HAD 1,356 INCOMING ANIMALS. WE ADOPTED 796 PETS TO NEW HOMES, AND 275 PETS WERE RECLAIMED BY THEIR OWNERS. OUR LIVE RELEASE RATE WAS 96%.
